Adult Participant Agreement

Please read carefully, sign and bring a copy to the 2027 ELCA Youth Gathering. This form will be required to receive a wristband.

I desire to participate in the Evangelical Lutheran Church in America's ("ELCA") 2027 ELCA Youth Gathering in Minneapolis, MN, June 28-July 2, 2027, Multicultural Youth Leadership Event ("MYLE") June 26-28, 2027, the tAble, June 26-28, 2027, and/or SERVE, June 28, 2027 (collectively "Gathering"). In exchange for being allowed to participate in the Gathering, and the benefits derived from such participation, I knowingly and voluntarily sign and agree to be bound by this Participant Agreement ("Agreement"):

1. ELCA DIRECTIONS, RULES, POLICIES AND PROCEDURES.

I shall abide by all ELCA directions, rules, policies and procedures for the Gathering. I acknowledge my Gathering responsibilities include providing continuous supervision and support of the youth I am responsible for supervising during the Gathering. I represent and warrant that I will be at least 21 years of age by June 26, 2027.

2. PUBLICITY RELEASE. I grant the ELCA and its ENGAGE exhibitors a worldwide, sub-licensable, perpetual, irrevocable, royalty free right (but not the obligation) to photograph, record (audio and visual), digitize, reproduce, distribute, prepare derivative works based on, publicly perform, publicly display, and otherwise use my name, image, likeness, voice, biographical information, and other personal characteristics as they may appear in photographs, recordings (audio and visual), writings, messages, artwork, and other materials (collectively, "Materials") related to the Gathering, in all formats and media now known or hereinafter created, for purposes related to the mission and ministries and its ENGAGE exhibitors, including advertising, trade and commercial purposes related to the mission and ministries of the ELCA and its ENGAGE exhibitors. I ACKNOWLEDGE THE ELCA IS THE OWNER OF THE MATERIALS AND I HAVE NO RIGHT TO INSPECT OR APPROVE THE MATERIALS OR THE ELCA'S USE OF THE MATERIALS.

3. SOCIAL MEDIA USE AND LICENSE. I understand the ELCA maintains various social network profiles, messaging accounts, blogs, listservs, chat rooms, websites, and other online forums (collectively, "ELCA Social Media") which allow users to post, submit, publish, and/or display (collectively, "post") text, images, recordings, (audio and visual) and other content (collectively, "User Contributions"). I understand ELCA Social Media is a public forum and not confidential and that I should not post anything I wish or am required to keep confidential. I understand that I am responsible for the content of my User Contributions. I represent that I will not post any content to ELCA Social Media which: (i) violates applicable law or the legal rights of another person; (ii) is defamatory, obscene, indecent, abusive, harassing, violent, hateful, sexually explicit, pornographic, or discriminatory; (iii) is likely to deceive another person; and (iv) I do not have the legal right to post. I grant the ELCA and its ENGAGE exhibitors a worldwide, sub-licensable, perpetual, irrevocable, royalty free right (but not the obligation) to reproduce, distribute, prepare derivative works based on, publicly perform, publicly display, and otherwise use for purposes related to the mission and ministries of the ELCA and its event exhibitors, in all formats and media now known or hereinafter created, any User Contributions I post to ELCA Social Media. I ACKNOWLEDGE I HAVE NO RIGHT TO INSPECT OR APPROVE THE ELCA'S USE OF MY USER CONTRIBUTIONS.

4. ASSUMPTION OF ALL RISKS. I acknowledge my decision to participate in the Gathering may expose me to various risks and dangers, including personal injury, death, and loss of or damage to my personal property. I KNOWINGLY AND VOLUNTARILY ASSUME ALL RISKS ASSOCIATED WITH MY PARTICIPATION IN THE GATHERING.

5. LIABILITY RELEASE, CLAIMS WAIVER AND COVENANT NOT TO SUE. TO THE FULLEST EXTENT POSSIBLE PURSUANT TO APPLICABLE LAW, I KNOWINGLY, VOLUNTARILY, AND IRREVOCABLY RELEASE FROM ALL LIABILITY INCLUDING NEGLIGENCE, WAIVE ALL CLAIMS AGAINST, AND COVENANT NOT TO MAKE OR BRING ANY CLAIM AGAINST THE ELCA AND/ OR ITS SEPARATELY INCORPORATED MINISTRIES AFFILIATES, DIRECTORS, OFFICERS, EMPLOYEES, AGENTS, VOLUNTEERS, REPRESENTATIVES, AND CONTRACTORS (COLLECTIVELY, "RELEASED PERSONS") IN ANY WAY ARISING OUT OF OR RELATED TO: (i) THE GATHERING; (ii) MY PARTICIPATION IN THE GATHERING; AND/OR (iii) THE ELCA'S EXERCISE OF THE RIGHTS GRANTED BY ME TO THE ELCA UNDER THIS AGREEMENT.

6. DEFENSE, INDEMNIFICATION AND HOLD HARMLESS. I SHALL DEFEND

AND INDEMNIFY THE RELEASED PERSONS AGAINST ALL CLAIMS, DEMANDS, LOSSES, DAMAGES, AND EXPENSES (INCLUDING REASONABLE ATTORNEYS' FEES AND COSTS INCURRED IN DEFENDING THE SAME), IN ANY WAY ARISING OUT OF OR RELATED TO: (I) THE ADULT PARTICIPANT'S CONDUCT, ACTIONS, OR OMISSIONS; (II) THE ADULT PARTICIPANT'S PARTICIPATION IN THE GATHERING; (III) THE RIGHTS GRANTED TO THE ELCA UNDER THIS AGREEMENT; (IV) MY OR THE ADULT PARTICIPANT'S BREACH OF THIS AGREEMENT; AND/ OR (V) ANY ACTION BY THE ADULT PARTICIPANT TO DISAFFIRM OR VOID THIS AGREEMENT.

7. NO FINANCIAL COMPENSATION. I shall not receive any financial compensation as consideration for this Agreement or the rights granted by me to the ELCA hereunder.

8. MISCELLANEOUS. This Agreement is governed by and construed in accordance with the substantive laws of the State of Illinois, excluding its choice of law rules. If any provision of this Agreement is invalidated or held unenforceable, the invalidity or unenforceability of that provision shall not affect the validity or enforceability of this Agreement. As to any provision found to be invalid or unenforceable as written, the same shall not be void, but rather shall be reformed and enforced to the maximum extent permissible under applicable law, as if originally executed in that form by me. If the ELCA agrees to waive its right to enforce any term of this Agreement, it does not waive its right to enforce the term, or any or all other terms, of this Agreement at any other time. If there is any conflict between the headings, captions, and/or numbers and the text of this Agreement, the text will control. This Agreement is binding on me and my heirs, executors, administrators, legal representatives, successors and assigns.

9. PARTICIPANT COVENANT AND CODE OF CONDUCT: As a participant in the ELCA Youth Gathering, I recognize that my actions impact the safety, well-being, and experience of others. I understand that this is a church-sponsored event grounded in shared values of respect, responsibility, and community. In order to attend the ELCA Youth Gathering, I agree to adhere to the following code of conduct and expectations.

Prohibited Conduct and Items: In addition to conduct that is unlawful, certain activities are prohibited at the Gathering regardless of whether they are otherwise legal. I agree to adhere to all of the following Gathering Code of Conduct provisions at all times while attending the ELCA Youth Gathering. Any violation may result in disciplinary action, up to and including immediate removal from the Gathering at the participant's expense, at the sole discretion of the Gathering event staff.

Gathering Code of Conduct:

- The manufacture, distribution, possession, or use of controlled substances in violation of law is strictly prohibited. This prohibition does not apply to prescription medications that have been lawfully prescribed to the participant and are used only by the participant and only in accordance with the prescribing healthcare provider's instructions. In addition, possession or use of any alcohol, cannabis, tobacco, vaping products, or other intoxicants is prohibited at the Event, regardless of legality.
- Any disrespectful behavior will be dealt with quickly and certainly. Participants who use inappropriate language, hate speech, or offensive language, or engage in destructive behavior, may be removed from the Gathering. Inappropriate language includes, but is not limited to, profanity, whether or not directed at others, harassment, threats, intimidation, or disruptive conduct, and will be enforced at the discretion of the Gathering staff.
- I will respect and care for all participants as siblings in Christ and will conduct myself in a manner that promotes physical and psychological safety, dignity, and inclusion. Respect and appropriate behavior will always be given to fellow participants and adults. The Gathering believes that groups have the right to express their views on a particular issue or cause. However, demonstrations should not interfere with the operation of the Gathering.
- Care should be taken to respect the individuals outside our event to make the Gathering possible, including bus drivers, police officers, security and medical personnel, and other venue and hotel staff, including front desk, concierge, and guest services.
- The Gathering will remain free of all sex, gender, and racial discrimination. Harassment, assault, and misconduct, as well as interpersonal violence, bullying, and stalking will not be tolerated. Any of the above behavior may result in immediate removal from the Gathering.

- Possession, use, or presence of any weapons or dangerous objects of any kind, including firearms, is strictly prohibited at the Gathering, regardless of whether such items are otherwise legally permitted.
- Sexual activity and conduct that is inappropriate for a supervised youth event, including public displays of sexual behavior or conduct that violates event supervision or lodging rules, is strictly prohibited.
- All Gathering participants shall always adhere to all venue and lodging rules and regulations.

Participation and Attendance: I agree to actively participate in scheduled sessions and events throughout the ELCA Youth Gathering, unless otherwise excused due to illness, safety concerns, or another approved reason.

Safety and Supervision: I understand that my safety and the safety of others are always the primary concern. I agree to follow all safety instructions as may be communicated.

Adult participants shall maintain appropriate physical, emotional, and electronic boundaries with youth at all times and will comply fully with all ELCA Youth Gathering policies related to supervision, interaction, and youth protection, as well as any mandatory reporting obligations under ELCA guidelines or applicable law.

Reporting Concerns: Gathering participants shall immediately address and report any safety, health, or crime-related concerns, including bullying, harassment, racial misconduct, drugs, online threats, fighting, weapons, or theft, to a designated adult leader, event staff member, or other appropriate authority. Adult participants should be especially aware of the conduct of, and be prepared to report, other adults who may violate these policies.

I understand that failure to comply with this covenant or with ELCA Youth Gathering rules and policies may result in my removal from the ELCA Youth Gathering at my expense.

I HAVE READ THIS AGREEMENT AND UNDERSTAND ALL OF ITS TERMS AND CONDITIONS. I UNDERSTAND THAT IF I SIGN BELOW, I AM ENTERING INTO A LEGAL AGREEMENT, WHICH WILL BIND ME TO THE TERMS OF THIS AGREEMENT, AND THAT BY SIGNING THIS I AM GIVING UP SUBSTANTIAL LEGAL RIGHTS, INCLUDING THE RIGHT TO SUE THE ELCA.
